ARTICLES OF INCORPORATION

We, the undersigned, for the purpose of forming a corporation under the State of Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation shall be: 911 Hurricane Control, Inc.

ARTICLE TWO

This corporation shall have perpetual existence, and its existence shall commence at the time of the filing of these Articles of Incorporation by the Florida Department of State - Division of Corporations.

ARTICLE THREE


ARTICLE EIGHT


