ARTICLES OF INCORPORATION of JILL A. SELBACH, Ph.D., P. A.

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I: NAME The name of the corporation is JILL A. SELBACH, Ph.D., P.A.

ARTICLE II: DATE The existence of the corporation shall begin on the date of the filing of the Articles of Incorporation.

ARTICLE III: PRINCIPAL OFFICE The street address of the principal office of the corporation is: 3650 North Federal Highway, Suite 209, Lighthouse Point, FL 33064.

ABTICLE IV: PURPOSE The corporation is organized for the purpose of rendering specific services as a psychologist.
