ARTICLES OF INCORPORATION

OF

SWEAT MECHANICAL INC.

ARTICLE I -CORPORATE NAME

The name of this corporation is: SWEAT MECHANICAL INC.

ARTICLE II- NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this business is (1) Equipment Repair and Maintenance, labor training and labor transportation (2) the foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.

ARTICLE III- CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock with no-par value.

ARTICLE IV - TERM OF EXISTENCE

This corporation shall have perpetual existence.
