# ARTICLES OF INCORPORATION OF SALON LORI, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of this corporation is SALON LORI, INC. The mailing address of the corporation is 809 S.E. 16 Place, Deerfield Beach, Florida 33441.

#### ARTICLES II - PURPOSE
