

A majority of the incorporators authorized the dissolution.

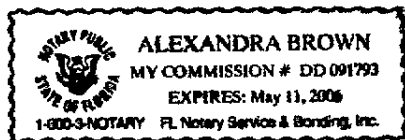
