**ARTICLES OF INCORPORATION
OF WILD ABOUT CURVES, INC.**

In compliance with the requirements of Florida Statutes, Chapter 607 and/or Chapter 621, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Wild About Curves, Inc.

ARTICLE II

The existence of the corporation shall begin on an effective date established when the Articles of Incorporation have been filed.

ARTICLE III

The address of the principal office of the Corporation is 465 S. Croft Avenue Inverness, Florida 34453. The mailing address of the corporation is the same..

ARTICLE IV

The maximum number of shares the Corporation is authorized to issue is one hundred shares (100), all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 465 S. Croft Avenue. The initial registered agent for the Corporation at that address is Julie A. Kirkland and the initial registered agent's address is 465 S. Croft Avenue, Inverness, Florida 34453.

ARTICLE VI

The initial board of directors shall consist of 2 members whose names are Julie A. Kirkland, President and whose address is Post Office Box 575 Ocklawaha, Florida 32183. Terri L. Motes, Vice President and whose address is Post Office Box 575 Ocklawaha, Florida 32183.

ARTICLE VII

The names and addresses of the incorporator signing these Articles of Incorporation is Julie A. Kirkland, Post Office Box 575 Ocklawaha, Florida 32183.

ARTICLE VIII

The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

ARTICLE IX

The corporation through its directors and shareholders reserve the right to file a Subchapter S election with the Internal Revenue Service.
