Per conversations with your offices, enclosed is a completed State of Florida Corporation Reinstatement Form for the above-referenced corporation.

In summary, somehow, this year, we did not receive our initial UBR Filing forms for either corporation (we have two) to submit our 2003 UBR Filing Report and fee on time. Therefore, when we received the second 2003 UBR Filing Reports with late fees (our first notice), we were concerned.

We immediately contacted the Division of Corporations offices to discuss the situation and notify them that we did not receive either 2003 UBR Filing Forms for either of our corporations. We were told to send in correspondence with our \$150.00 fees for each corporation (one being the above-referenced corporation) and they would consider waiving the late fees. We did this immediately (correspondence with attachments enclosed).

On September 10, 2003 we received a letter from your office (copy enclosed) stating that the annual report for H & T Enterprises, Inc. had not been filed and a copy was being returned to us for correction, inclusion of the Federal Employer Identification Number was necessary. We inserted the Federal Employer Identification Number on the UBR form and returned the corrected report on September 30, 2003 (to the address listed in the letter the same address used to mail in the initial 2003 UBR Filing Reports) which was within the 30 day timeframe to avoid dissolution. This corrected letter has never been returned to us to date.

A few weeks passed and we received a Notice of Administrative Dissolution in the mail. We immediately contacted the Florida Division of Corporations offices to inquire of the Notice. We were told that the corporation had been administratively dissolved and that the corrected UBR Report was not received or was still being processed and that we should wait a few weeks and see if the process gets completed. Upon waiting approximately three - four weeks, we again contacted the Florida Division of Corporations office and was told that the corrected 2003 UBR Filing Report was never received. However, our check in the amount of \$150.00 cleared the bank in mid September 2003. We inquired as to what steps to take to rectify the situation and were directed to print a Corporation Reinstatement Form off the Florida Division of Corporations website, to complete the form, write a letter explaining the situation and send it in to your offices. Hence, this correspondence with enclosed completed Corporation Reinstatement form.

We hope this correspondence and Reinstatement Form will correct the situation with respect to the above-referenced corporation.

Please advise us immediately if there is a problem with the reinstatement of this corporation.
