**ARTICLES OF INCORPORATION  
OF  
RJR ACQUISITIONS, INC.**

The undersigned, acting as incorporator of a corporation, hereby adopts the following Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

**ARTICLE I  
NAME AND ADDRESS**

The name of the corporation is **RJR ACQUISITIONS, INC.** and the principal office address is **117 Dianne Drive, Ormond Beach, Florida 32176.**

**ARTICLE II  
NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III  
CAPITAL STOCK**

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is **one hundred (100)** shares of common stock, each share having the par value of **One Dollar (\$1.00)** per share.
