# ARTICLES OF INCORPORATION

The undersigned incorporator to these Articles of Incorporation, all of whom are duly licensed and competent to contract for residential and commercial painting services and all related services, hereby forms a corporation for profit pursuant to the provisions of the Florida Business Corporation Act and other laws of the State of Florida.

#### ARTICLE I

# **Name**

The name of this corporation is: Mid Town Painting, Inc..

#### ARTICLE II

#### Existence

The corporation's existence shall commence on July 3, 2002.

#### ARTICLE III

# Nature of Corporate Business and Powers

The general nature of the business to be transacted by this Corporation shall be:

- A. To engage in every aspect and phase of residential and commercial painting services and all related services authorized to render.
- B. To invest and reinvest the funds of this corporation in real estate, mortgages, stocks, bonds of any other type of investments within the meaning of Chapter 621.08, Florida Statutes, and to acquire and own real and personal property necessary for the rendering of professional services.

- C.
