

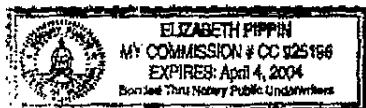
2. Success Development, Inc. was dissolved by the Florida Secretary of State pursuant to Section 607.1403, Florida Statutes, on May 29, 2003.

ACADEMY OF FINANCIAL FREEDOM, INC., a Florida corporation ("Corporation"), pursuant to Section 607.1006, Florida Statutes, does hereby file the following Second Amendment to the Articles of Incorporation:

1. That the name of the Corporation is ACADEMY OF FINANCIAL FREEDOM, INC. The Corporation was assigned document number P02000072086.
2. That Article I of the Articles of Incorporation of ACADEMY OF FINANCIAL FREEDOM, INC. is hereby amended to read as follows:

"ARTICLE I
NAME AND DURATION

The name of the Corporation is Success Development, Inc. The duration of the Corporation is perpetual. This Corporation shall begin its corporate existence as of the date these Articles are filed by the Secretary of State."

3. That the foregoing amendment was approved and adopted by the sole member of the Board of Directors and the sole shareholder of the Corporation, by a written action dated May 22^d, 2003, pursuant to Section 607.0704, 607.0821 and 607.1003 of the Florida Statutes. The number of votes cast by the Shareholders was sufficient for approval.
