ARTICLE I. NAME

The name of this corporation is Reel Boats Inc.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles.

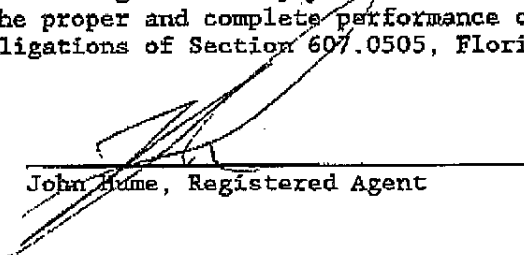
