ARTICLES OF INCORPORATION

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a Professional Association under the laws of the State of Florida.

ARTICLE I - NAME

The name of the professional association is LAW OFFICES OF DAVID R. PAZ, JR., P.A.
