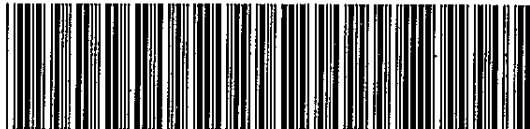


ARTICLE VI - ADOPTION OF DISSOLUTION


