Article VI: The purpose of the corporation is to engage in any desired lawful business activity for which a corporation may be organized under the Florida Business Corporation Law.

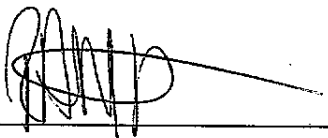

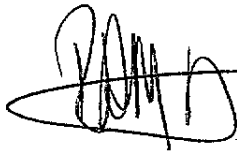
