Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that.

ARTICLE ONE

The name of Corporation is NATURAL WORLD MARKETING, CORP. (The "Corporation")

ARTICLE TWO

This corporation shall have perpetual existence, and its corporate existence shall commence at the time of the filing of the Article of Incorporation by the Department of State.

ARTICLE THREE

The Corporation shall engage in any activity of business permitted under the laws of the United State and the State of Florida.

ARTICLE FOUR

The aggregate number of shares which this corporation shall have authority to issue is 100 shares of Common Stock, par value ten dollars (\$10) per share.

The power to adopt, alter amend or repeal bylaws shall be vested in the Boars of Directors and the shareholders.

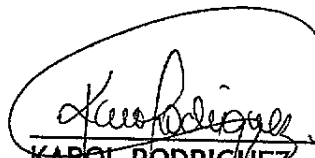
ARTICLE NINE
