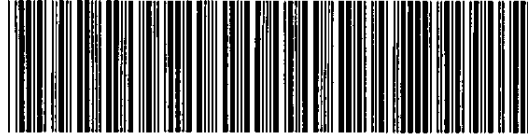

FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE came on before the Court on May 21, 2015 upon the Wife's Petition for Dissolution of Marriage and the Court having taken testimony from the parties, and being apprised that a Marital Settlement Agreement dated May 20, 2015 has been voluntarily entered into between the parties, on the evidence presented, the Court finds:

1. The Court has jurisdiction of the subject matter, and the parties hereto.
 2. The parties were married on November 25, 1985.
 3. The marriage between the parties is irretrievably broken.
 4. Both parties have been residents of Florida for six (6) months immediately preceding the filing of Wife's Petition.
 5. The parties entered into a Marital Settlement Agreement on May 20, 2015.

Based upon the foregoing, it is hereby ADJUDGED as follows:

A. The marriage between Petitioner/Wife, **PEGGY HUERLANDER** and Respondent/Husband, **MATHEW HUERLANDER**, is hereby dissolved *a vínculo matrimonii*.


B. Upon entry of this Final Judgment, Wife's name shall be restored to her maiden name: **PEGGY KEOGH GOTTE**.
