

NAME

The name of this corporation is ILLUSTRATED 5, INC.

ARTICLE II

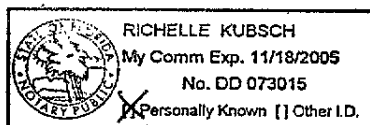
