The name of the corporation shall be: Laroye Investments, Inc.

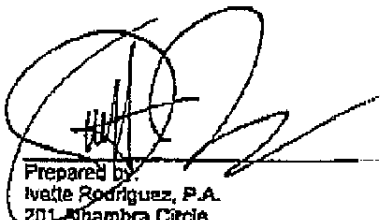

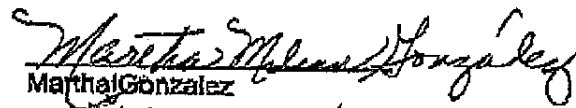
