ARTICLES OF INCORPORATION

OF

COIN ROUTE OPERATION, INC.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of the corporation ("Corporation") is COIN ROUTE OPERATION, INC.

ARTICLE II - CORPORATE DURATION

This corporation shall have perpetual existence and shall commence upon the filing of these Articles of Incorporation.

ARTICLE III - CAPITAL STOCK
