The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is BB Management Services, Inc.

ARTICLE II

DURATION AND PLACE OF BUSINESS: The corporation shall exist perpetually and the principal place of business shall be 465 East Royal Flamingo Drive, Sarasota, Florida 34236.

ARTICLE III

PURPOSE: The corporation is organized for the purpose of management services and transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV

CAPITAL STOCK: The corporation is authorized to issue 1,000 shares of stock having a par value of \$1.00 per share, all of which shall be common shares.

ARTICLE V

REGISTERED OFFICE AND AGENT: The street address of the initial registered office of the corporation is 1133 4th Street, Suite 300, Sarasota, Florida 34236, and the name of the initial registered agent of the corporation at that address is Albert A. Sanchez, Jr., P.A.

CORPORATE EXISTENCE: This corporation shall commence its existence at the time of filing these Articles of Incorporation with the Department of State, Division of Corporations, State of Florida.

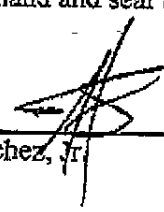
