The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida. SECRETARY OF STATE
TALLAHASSEE FLORIDA

ARTICLE I. NAME.

The name of the corporation shall be: JAZ MAZ, INC.

ARTICLE II. ADDRESSES.

The address of the principal office of this corporation shall be 1200 Brickell Avenue, Suite #950, Miami, FL 33131 and the mailing address of the corporation shall be the same. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE III. NATURE OF BUSINESS.

This corporation may engage or transact in any and all lawful activities and businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV. CAPITAL STOCK.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having \$.01 par value per share.
