ARTICLE I - Name

The name of this corporation is 1ST CHOICE HOME HEALTH, INC.

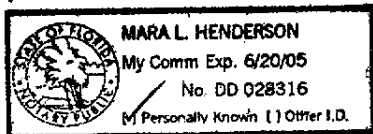


