

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is ENVIRO SPRAWL ASSOCIATES, INC.

ARTICLE II.

The main location where the company shall conduct its business is 4061 Green Street, Jacksonville, Florida 32205.

The duration of the corporation shall be perpetual.
