ARTICLES OF INCORPORATION OF GEOGRAPHIC CONSULTANTS, INC.

The undersigned, being of legal age and desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the Florida Business Corporation Act, as amended (such Act, as amended from time to time, is hereinafter referred to as the "Act"), executes the following Articles of Incorporation.

ARTICLE I

<u>Name</u>

The name of the Corporation shall be GEOGRAPHIC CONSULTANTS, INC.

ARTICLE II

Initial Registered Office and Agent; Principal Place of Business


