ARTICLES OF INCOPORATION OF CK CONSTRUCTION SERVICES, INC.

The undersigned, for the purpose of forming a corporation under the Floridal General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE. NAME

The name of the corporation is CK Construction Services, Inc.

ARTICLE TWO. DURATION

The duration of the corporation is perpetual
