RODOLFO CHAVES undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida

1. The name of the Corporation is. Colombia Contractors Inc..
7761 NW 47 Ct. Lauderhill- Fla 33351
2. The number of shares the corporation is authorized to issue shall be ten thousand (10,000) shares all of one class designated as common stock.
3. The street address and county of the initial registered office of the corporation is

and the name of the initial registered agent at this address is Rodolfo Chaves, 7761 NW 47 Ct. Lauderhill Fl. 33351.

5. To the fullest extent permitted by Florida (STATE) Business Corporation Act as it exists or may hereafter be amended, no person who is serving or who has served as a director of the corporation shall be personally liable to the corporation or any of its shareholders for monetary damages for breach of duty as a director. No amendment or repeal of this Article nor the adoption of any provision of these Articles of Incorporation inconsistent with this Article shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal, or adoption.

6. The corporation elects to have pre-emptive rights.

7. All shareholders of the corporation are entitled to accumulate their votes for directors. No amendment shall be made to this Article when the number of shares voting against the proposal to amend would be sufficient to elect a director by cumulative voting and such shares are entitled to be voted cumulatively for the election of directors.

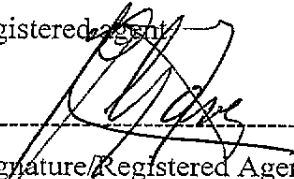
