ARTICLES OF INCORPORATION OF BULLDOG LEATHERS, INC.

The undersigned, acting as incorporator of a corporation, hereby adopts the following Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I NAME AND ADDRESS

The name of the corporation is **BULLDOG LEATHERS, INC.** and the principal office address is **817A Main Street, Daytona Beach, Florida 32118**.

ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.
