ARTICLE I - NAME

The name of this corporation is NATION'S LOANS, INC., with its principal office and address being located at 1000 W. Oakland Park Blvd., Ft. Lauderdale, FL 33311.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.
