ARTICLE I - NAME

The name of this corporation is McGUINNESS'S SLY FOX, INC., with its principal office and address being located at 3537 Galt Ocean Drive, Fort Lauderdale, Florida 33308.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

ARTICLE IX - INDEMNIFICATION

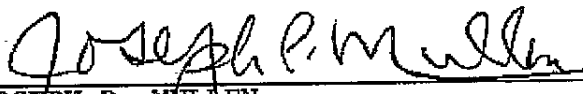
The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

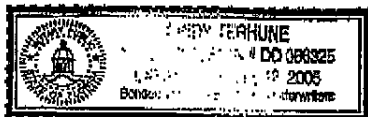
