**ARTICLES OF INCORPORATION

The undersigned natural person, competent and licensed to practice real-estate in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I**

The name of this professional service corporation is R.J. KRAUSS, P.A.

**ARTICLE II**

The street address of the principal office of the corporation is 2925 1<sup>ST</sup> Street N.E., St. Petersburg, Florida 33704.

**ARTICLE III**

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of real estate and all its fields of specializations.
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be realtors in good standing and duly licensed within the State of Florida to render the same professional service as this corporation.
- c. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
- d. To engage in no other business other than the rendition of the professional services specified herein.
- e. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.
