Today, when I attempted to print out the Articles of Incorporation for Florida Discount Realty Inc, I saw that the corporation was dissolved for not submitting the required yearly report.

Since I opened my company with very little money and without expert help, I wasn't aware of the fact that I had to submit a report and a fee on a yearly basis.

I also didn't know that I had to submit an address change. When I found out I immediately sent in a change of address for the corporation. However, I never received the report forms, because the address change was too late and mail wasn't forwarded from the old place of business.

This is the second year for my company and payment of the reinstatement fees (a minimum of \$750) is impossible due to a lack of funds.
