

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

JohnMur, Inc.

The address of the principal office of this Corporation shall be 800 Cypress Pointe Drive East, Pembroke Pines, Florida 33027, and the mailing address of the Corporation shall be the same.

ARTICLE II

The period of duration of the corporation shall be perpetual.

ARTICLE III

The purpose for which the Corporation is organized is to engage in all lawful business activities permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV

The corporation shall be authorized to issue 10,000 shares of common stock, all of one class.

ARTICLE V


ARTICLE VI


