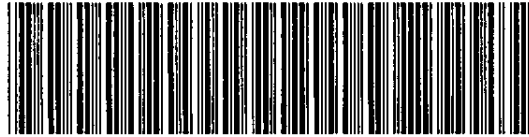

ARTICLE II. DOCUMENT NUMBER


