

- . 6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is 1,000 Shares of common stock, each share having the par value of 1.00
- 6.2 No holder of shares of stock of any class shall have any preemptive right to subscribe to or purchase any additional shares of any class, or any bonds or convertible securities of any nature; provided, however, that the board of directors may, in authorizing the issuance of shares of stock of any class, confer any preemptive right that the board of directors may deem advisable in connection with such issuance.

#### ARTICLE 10 - TITLE


