ARTICLE I
NAME

The name of this Corporation is

PURPOSE

CAPITAL STOCK

ARTICLE VIII
INDEMNIFICATION

The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which that person may be entitled.

BY-LAWS

The first By-Laws of this Corporation shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the By-Laws.

ARTICLE X
AMENDMENTS


