

Articles of Incorporation

ARTICLE I. CORPORATE NAME

The name of this Corporation is International Medical Care, Inc.

ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS

The Corporation principal office and mailing address 656 Bellingham Place, Palm Harbor, FL 34684.

ARTICLE III. NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is to engage in any business as permitted under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK

The maximum number of share of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock without par value.

ARTICLE V. TERMS OF EXISTENCE
