ARTICLES OF INCORPORATION  
OF  
TRAVELLER'S PARADISE, INC

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is Traveller's Paradise, Inc.

The term of existence of the corporation is perpetual.
