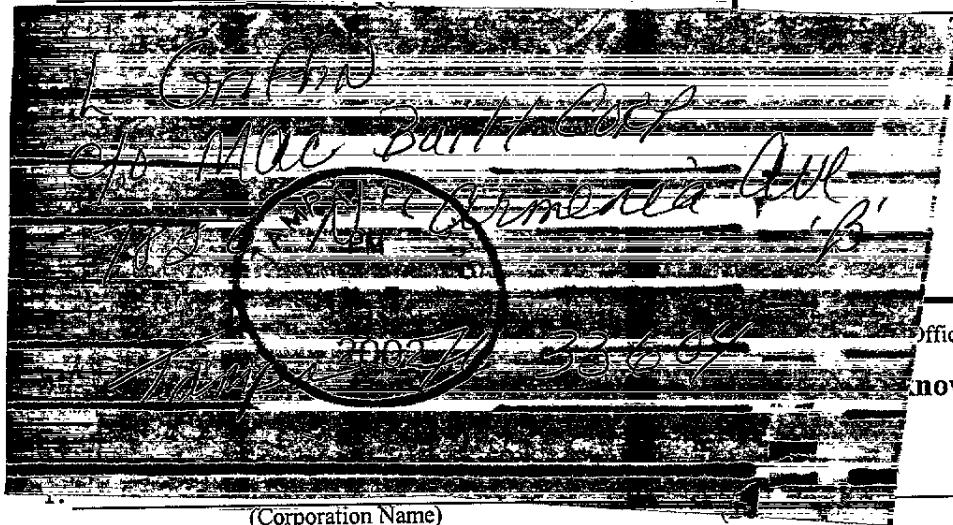

1.01 THE NAME OF THE CORPORATION IS CITISCRIPTS, INC.
