The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit, under Chapter 607, Florida Statutes, and do hereby certify that it has become such corporation under and pursuant to the following Articles of Incorporation.

#### ARTICLE I Name

The name of the corporation is "S & L PRESSURE WASHING, INC."

# ARTICLE II Duration

The corporation shall have perpetual existence, commencing on the date of filing of this agreement.

# ARTICLE III General Purpose Clause

The general nature of the business or businesses to be transacted by the corporation is that it will engage in commercial pressure washing services, and to receive any contracts or assignments of contracts therefore or related thereto or connected therewith and to deal in and deal with any materials, equipment, devices or wares or anything incidental to or required for or
