# STATE OF FLORIDA ARTICLES OF INCORPORATION BIRDIES ORIENTAL OUTLET, INC.

OR III 5 PH 3: I'm The undersigned acting as an incorporator of a corporation under the Florida General corporation act, adopts the following Articles Of Incorporation for such corporation:

- 1. The name of this corporation is Birdies Oriental Outlet, Inc.
- 2. The period of this corporation is perpetual.
- 3. The corporation may engage in any activity or business permitted under the laws of the United States and of this State.
- 4.
