On July 2, 2002, articles of incorporation for ANJO, INC. were rejected due to name unavailability. (See computer printout included with this letter.)



ARTICLE I

NAME

The name of the corporation shall be AnJo of Skylake, Inc.

ARTICLE II

GENERAL NATURE OF BUSINESS



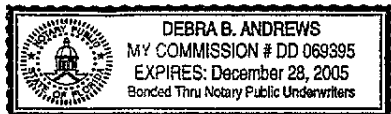


