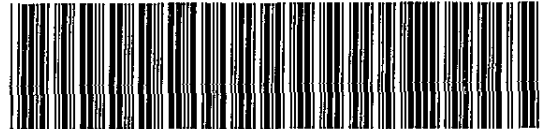

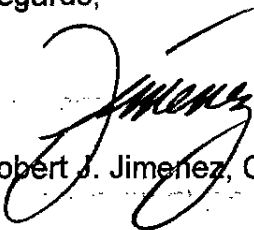
This letter is written in response to your letter number 402A00052744 dated September 16, 2002 stating the need to pay a fee and file articles of dissolution.
