

ARTICLE ONE

The name of the corporation is Farhana Hossain, Inc., and its principal office is at 711 58th St. S. #Apt 3, St. Petersburg, FL 33707.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is to acquire and operate an ice cream parlor and to perform any services or business incidental thereto. Further, the purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR
