Article 1: The name of the corporation shall be: DIACOM CORP.

Article 2: Principal place of business/ mailing address is 19585-0 South State Rd. 7, Boca Raton, Fl 33498

Article 3: The purpose for which the corporation is organized is for transacting any or all lawful business including but not limited to :

Article 6: The initial registered agent is Jeff Wasserman at 7040 W Palmetto Pk Rd #4-464, Boca Raton Fl 33433


