**ARTICLE I:**                   The name of this corporation is **ADVANCED K-9 SERVICES, INC.**

**ARTICLE II:**                This corporation shall have perpetual existence.

**ARTICLE III:**             This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States or the State of Florida.

**ARTICLE IV:**             The maximum number and class of shares of capital stock which this corporation is authorized to have outstanding is five hundred shares of common capital stock with a par value of One Dollar (1.00) per share.

**ARTICLE V:**              The initial principal office of this corporation shall be at 2703 N.W. C.R. 125, Lawtey, Florida, 32058, and the name of the corporation's initial registered agent is **JACK ETHERIDGE, SR., At 350 E. Forysth Street, Jacksonville, Florida 32202.**

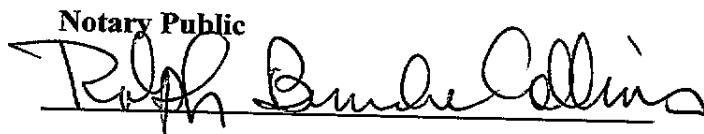

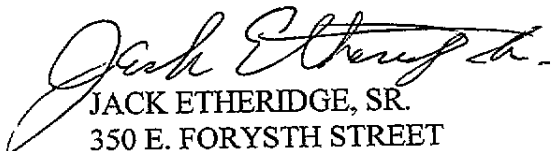
