ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is HIT PARTNERSHIP AUSTRALIA, INC. and its principal place of business shall be located at 1406 Hays St., Suite 2, Tallahassee, FL 32301.
