**ARTICLES OF INCORPORATION
OF**

ART INVESTMENTS GROUP, INC.

We, the undersigned, do hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

ARTICLE I

THE NAME of the Corporation shall be:

THE CORPORATION may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

The number of the Directors, not less than one, shall be fixed by resolution of the stockholders at any regular or special meeting, subject to the manner of holding such meetings prescribed by the by- laws.


ARTICLE XII
