The undersigned incorporator to these articles of incorporation adopts these articles to form a corporation in compliance with the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621 and Chapter 607 and other laws of the state of Florida.

ARTICLE I. NAME

The name of the professional service corporation is JUDITH A. CURTS, LCSW, P.A.

ARTICLE II. PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 15310 Amberly Drive, Suite 250-42, Tampa, FL 33647.

ARTICLE III. PURPOSE


ARTICLE VIII. INCORPORATOR

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.


