# ARTICLES OF INCORPORATION OF

### 153RD STREET INVESTMENT, INC.

## ARTICLE I

The name of this corporation is 153°D STREET INVESTMENT, INC.

### ARTICLE II

This corporation shall have perpetual existence, unless sooner dissolved by law, commencing on the date of filing of the certificate with the Secretary of State of the State of Florida.

## ARTICLE III PURPOSE

#### ARTICLE IV CAPITAL STOCK

#### ARTICLE IX BYLAWS

The private property of the stockholders shall not be subject to the payment of corporate debts to any extent whatsoever. The corporation shall have a first lien on the shares of its stockholders and upon the dividends due them for any indebtedness of such stockholders to the corporation.
