**ARTICLE I
NAME**

The name of this corporation is 153RD STREET INVESTMENT, INC.

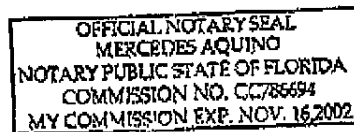
